

11. PACIFIC NORTHWEST CHAPTER (PNW) (1959)
Alaska, Idaho, Montana, Oregon and Washington

- Oregon Section with territory the state of Oregon
- Washington Section with territory the state of Washington

Western Pennsylvania Section - with territory of the Erie, Warren, Crawford, Mercer, Benango, Forest, Clarion, Lawrence, Butler, Jefferson, Cambria, Washington, Westmoreland, Armstrong, Beaver, Greene, Somerset, Indiana, Allegheny and Fayette Counties

Worth Section with territory of Archer, Bosque, Clay, Collin, Cooke, Comanche, Dallas, Delta Denton, Eastland, Ellis, Erath, Fannin, Grayson, Hamilton, Henderson, Hill, Hood, Hopkins, Hunt, Jack, Johnson, Kaufman, Lamar, McLennan, Montague, Navarro, Palo, Pinto, Parker, Rains, Rockwall, Smith, Somerville, Stephens, Tarrant, Van Zandt, Wichita, Wise, Wood and Young Counties.
- 18. UPSTATE NEW YORK CHAPTER (U) (1954)

Northern and western New York State (to include Delaware, Schoharie, Albany and Rensselaer counties)
